-ATOMACON will be held November 31- December 2, at the Hilton Garden Inn in North Charleston, SC. .

The rates are as follows:

Dealer's Room:

\$100 for Table plus 1 badge. (A limited number of multiple table spaces are available).

You may bring additional displays.

Artist Alley:

Artist Alley -\$50 includes a classroom size table, and 1 badge. These are in the hallway and very limited. Only print artists will be accepted and you must remove your items (not displays) each night.

Companion badges-\$25 (**Limit one per table**)

WIFI and Power are Free. Chairs will be provided.

A boxed Lunch will be delivered to your table on Saturday around 1pm. The cost will be \$10 (the remainder subsidized by the convention) The lunches will be a sandwich, chips, pasta salad, apple, cookie, and drink or a Salad, dessert, and drink) Choices TBD. Must be paid for in advance.

Set Up: Friday, November 31 from 9 am-3pm. **Breakdown** by 5 pm Sunday, December 2.

Dealer's Room hours are:

Friday: 3 pm-9 pm

Saturday-10 am- 7pm (we may open at 9am if agreed on by all the dealers)

Sunday-10 am -3pm (we may open at 9am if agreed on by all the dealers)

NOTE: This is a Juried Dealer's Room. ATOMACON reserves the right to refuse sale of dealer's space if the committee does not feel that it is in the best interest of the dealer or other dealers booked to do so or if the wares sold do not support the family friendly atmosphere.

ATOMACON cannot hold dealer spaces until **paid in full**. Payment can be made via snail mail, or through our PayPal account atomacon@gmail.com. Please check with the dealer's director to make sure space is available before paying for the space.

Cancellations:

No refund after Aug. 1 2017. Requests will be handled on a case by case basis. If ATOMACON cancels, dealers receive a full refund.
